# NOTE FROM THE DIRECTOR

2019 was a blur. It was also the year that I got my first prescription glasses. Coincidence? I think not! Your Community Foundation had so many irons in the fire; it was hard to keep pace. As rewarding as it is to see the variety of grants and the many scholarships that were given out, it was so much more rewarding to work with a great group of like-minded people to work towards bringing more amenities to our community. Working with the "Stellar Group", which included Mayor Dan Manus, Bryan Robbins and Amy Borns of Economic Development, Jeff Emsweller and Dawn Lowe of the Chamber, Philip Deiwert of Tourism, Terrah Nunley and board members of Main Street Greensburg, David Fry and others that popped in and out of our meetings, we accomplished some great things.

The Splash Pad at Rebekah Park seemed like it took forever to get started, but it sure didn't take long for the community to grow to love it. No matter the temperature, kids could be seen out there playing in the fountains even though their lips were turning blue! The improvements along Main Street took a summer to get accomplished, but the end result is a much safer route for pedestrians to travel, AND our office and others along the route no longer flood when there is a downpour. The elderly can take a break on the benches along the sometimes long walk to get a piece of pie.

Using money provided through a Lilly GIFT (Giving Indiana Funds for Tomorrow), we took advantage of Lilly Endowment's generosity and attended the Kansas Conference for Community Foundations and found out that we have even more that we could be doing. Having board members take advantage of several training opportunities strengthened our board as a whole, and the team that we are going into 2020 with is ready to do some serious change-making. This really is YOUR community foundation. We are lucky enough to work here and seriously want to hear from the community on what sort of needs aren't being met. Our doors are open, and we are ready to listen.

We have been working on implementing a new software system and went live with the basic accounting in April. Since then, we've trained continuously to learn its capabilities and to implement it as fully as possible. Ultimately, the public will have the power to review a fund catalog on our website. They will be able to choose which fund they might want to support with their donations. Fundholders will be able to view their fund activity privately and ultimately even determine where they would like to send their donor-advised funds. As we work to implement all of these changes, we appreciate those of you who have allowed us to test our new knowledge on you!

The team in place at your foundation all care deeply about the community. This is more than just a job to them and each of them are involved in the community in a variety of ways. In 2019, office staff had spots on the Tourism Board, the Arts and Cultural Council Board, the Kids' Closet Board, the Animal Shelter Board , the Arc of Decatur County, and All4One.

Being involved is part of what we do as your Community Foundation.

# PRESIDENT'S MESSAGE



Dear Friends,

It was an honor to serve as the President for the Decatur County Community Foundation in 2019.

The Foundation is blessed to have an outstanding staff who keep things running smoothly, and I thank them for all they do. Also, I would like to recognize and thank three Board of Directors who retired at the end of the year. Mary Miers, Vince Rettig, and Dick Glaser provided invaluable guidance during their time on the board. The Foundation also has several committees made up of individuals who play a critical role, and I would like to thank them for their service.

Some of the more noteworthy accomplishments in 2019 included a major review and updates to the Investment and Spending Policies. The staff also put together a very successful Trades Fair for area high schools that was well received by the community. It is intended to become an annual event that introduces students close to graduating to the various trades that are available. Trades people from nearly 30 different occupations were on hand to talk to students. It was especially gratifying to receive \$401,737 in new donations. With Lilly Endowment rolling out GIFT VII, \$196,208 of those new donations were eligible to receive an additional \$392,416 in matching dollars. When GIFT VII ends, the Community Foundation will have received \$500,000 in match money for \$250,000 in donations eligible for the \$2-for-\$1 match. That will increase our grant-making funds by a total of \$750,000. Lilly Endowment's GIFT stands for "Giving Indiana Funds for Tomorrow" and their generosity has definitely had an impact on foundations across Indiana.

And, because it really isn't just about growing our funds, earnings on our assets allowed the Decatur County Community Foundation to gift \$1,115,256 back into our community in 2019. That amount includes a large number of scholarships and many types of grants to nonprofits.

Lastly, I would like to thank all of the donors who have confidence in the Foundation and support its continued growth.



You can support your favorite cause, charity, or nonprofit organization through a gift to the Community Foundation - now or later. Giving to the **Community Foundation is** flexible in that you can give to an existing fund or establish your own. You can also choose to make a gift to a Community Fund, allowing the Community Foundation to make grants that impact the lives of the community's residents. Whichever option you select, be assured that your donation will be used as directed.

The Community Foundation is able to accept a wide array

of assets as contributions to a fund. As the Community Foundation is a 501(c)(3) charitable organization, donors will receive the most valuable tax benefits available under the law.

# Ways you can make an outright gift today include:

**Cash** is the easiest way to contribute, whether it is actual cash or a check. The Community Foundation's online giving platform is a convenient way to give using a credit card or a debit card.

Appreciated securities, when

donated, allow you to avoid paying the capital gains tax while providing an accompanying income tax deducation for the current fair-market value.

**IRA charitable rollover** provides several benefits. If you are age 70 1/2 and older, you may make a gift up to \$100,000 from your IRA directly to the Community Foundation. You can specify the way your gift will be used for the betterment of Decatur County while paying no taxes on the transfer. You can also use the gift to count against the Required Minimum Distribution (RMD) from your IRA. Congress does not allow you to create a donor-advised fund with an IRA Charitable Rollover.

**Transferring life insurance** with the Community Foundation named as the beneficiary and owner of an existing or new policy, allows you an immediate tax deduction, which usually approximates the cash surrender value of the policy.

**Private foundations or trusts** often require significant time and money to manage. By transferring your private foundation or charitable trust to the Community Foundation, all responsibilities for reports and administrative duties will be carried out by the staff of the Community Foundation, which allows you to focus on the charitable purpose. Since the Community Foundation is a public charity and does not pay excise tax, more income is available for charitable purposes.

A **deferred gift**, made through your will or estate plan, will provide you the opportunity to support the Community Foundation in the future.


The Community Foundation will work cooperatively with you and your financial planner, attorney, or accountant to create an endowment that will ensure that your wishes are properly followed when the gift is ultimately received. The following are considered to be deferred gifts:

- A testamentary gift, or bequest in your will, is one way you can create your charitable legacy.
- A charitable remainder trust allows you or someone you choose to receive an income for life from assets transferred to a trust. Creating a charitable remainder trust also qualifies for a current charitable deduction, the amount of which is determined by the age of the income recipient and the payout rate. When the trust ends, the trust remainder is placed in a permanent fund in your name in the Community Foundation, with the charitable distributions made in accordance with your wishes.
- A **charitable gift annuity** is a simple way to make a substantial gift while retaining the right to a fixed annual income for life. Once the income is no longer paid, the remainder supports the charitable cause you have selected.

• A **charitable lead trust** allows the Community Foundation to receive an annual payment during your lifetime or for a specified number of years. When the trust terminates, the principal is returned to you or others you have designated.

**Real estate or personal property** may be given to the Community Foundation. Of course, all gifts qualify for a charitable tax deduction in the year the gift was made in accordance with IRS.

Acknowledgement: All individuals giving to the Community Foundation are acknowledged for their gift, regardless of size. Should an individual prefer anonymity, the Decatur County Community Foundation protects the identity and confidentiality of the individual.
